THE COURT ORDERS THAT:

1. Leave be granted to the plaintiff nunc pro tunc pursuant to s 490(1)(a) of the *Corporations Act 2001* (Cth) ('Act') for the defendant, Yitrikas Pty Ltd (ACN 600 483 314) to resolve that it be wound up voluntarily on 22 November 2023 and that the plaintiff, Matthew Kucianski, be appointed liquidator of the company on and from that date.

- 2. The plaintiff's costs associated with this application be costs in the liquidation of the defendant.
- 3. The costs incurred by the petitioning creditor, Alesci Distribuzione Pty Ltd (ACN 007 200 197), in the winding up proceeding filed on 20 November 2023 in the Supreme Court of Victoria in proceeding S ECI 2023 05445 be fixed in the sum of \$4,000 and payable in accordance with s 556(1)(b) of the Act.
- 4. Pursuant to s90-15 of the Insolvency Practice Schedule (Corporations) of the Act in relation to the external administration of the defendant, that s 91 of the Act operates such that the relation back day be fixed at the date on which the winding up proceedings were filed, namely, 20 November 2023
